Trainer Candice Morel was issued a \$200 monetary penalty for making a late equipment change on the horse No Angel Like Me in Race 8 this evening. AGCO Rule 22.25. Ruling #3140991.

Driver Bob McClure was issued a \$300 monetary penalty for failing to drive when programmed in Races 1,2 and 5. AGCO 6.02(a). Ruling #3141091.
