### Report on day's events:

#### Office:

- Early Judges scratch (transportation) of SUN CHIP (Patrick Dillon trainer) from the third race.
- Early Veterinary scratch (sick) of DA CINNAMONCRUNCH (Macy Cassell trainer) from the second race; this horse is entered on the short term (seven days) Veterinarians list.
- Review held with driver Ryan Guy regarding a possible violation of AGCO rule 22.05.01(i) (leave a hole when it is within the capacity of the horse to keep the hole filled) while driving SILVERADO in the tenth race on 30 April; after discussing the race video and the driver obligations regarding this rule and considering the explanation of the participant no penalty is assigned.

#### Races:

  4. Reviewed race pace concerning the race winner #2 TIGNANELLO (Ryan Guy) relative to the second quarter (26<sup>4</sup> 56<sup>4</sup>); the panel did not consider that #2 impeded any of the trailing horses or violated AGCO rule 22.05.01(k) (pace comparable to class). Clear.

5. Late Veterinary scratch (sick) of ILLUSIONISTE GALE (Jerome Lombart trainer); this horse is entered on the short term (seven days) Veterinarians list; refund: \$55. Clear.
6. Reviewed racing after the ¼ mile pole between #2 BIG PETES STYLE (Pascal Berube) and #5 ATEYATEFNGERSLOUIE (Ryan Guy); #5 did have clearance to move to the rail as #2 lost several lengths which Mr. Berube attributed to an equipment change being required.

The #8 HELLAS ROCKET suffered broken equipment (shoe) after the ½ mile pole and finished with broken equipment. Clear.

7. The driver of #2 MAKE IT COME TRUE, Guy Gagnon, was reminded, and cautioned, regarding a drivers' obligation when cutting the mile relative to AGCO rule 22.05.01(k) (pace comparable to class). Clear.
8. The driver of #6 MONTYSGONEMARBLE, John Macmillan, was cautioned regarding his urging in the last 3/8 mile. Clear.
9. Inquiry concerning possible interference by #7 SEA LAIRD (William Roy), who finished fourth, on #6 NO TIME AT ALL (Pascal Berube), who finished fifth, after the start; after reviewing the race video and speaking with Mr. Berube (stated he was not interfered with by #6) it was determined there were no violations and no placings were required. Clear.
