Ruling #3129411: Trainer Cassidy Schneider in to see the judges re: Certificate of Adverse Analytical Finding for Flunixin from a blood sample (sample ID #MX049411) drawn from the horse State of Treasure Tattoo #6SN09) on January 2, 2025, after the horse qualified to come off the long-term vet list at Western Fair Raceway. A penalty of \$500.00 is hereby issued for violation of AGCO Rule 6.54.02.

The resulting Stable Inspection (#2974926) was completed January 8, 2025, at which time it was determined that an unlicensed veterinarian has been working on racehorses at the Schneider property. A further penalty of \$500 is hereby issued for violation of AGCO Rule 26.17. Trainer Cassidy Schneider is also required to complete the AGCO Equine Medication Use and Awareness Program by May 31, 2025.
