Race 1 – #5 "Crafty Oaks" unseated Emma-Jayne Wilson in the post parade and ran off, scratched by the Stewards. #2 "Classy Image" ridden by Jose Campos was unruly in the gate and scratched by the official veterinarian. Combined refund of mutuels, \$74,964.

Race 2 – Stewards Inquiry into the run away from the gate involving #1 "Canadian Avro" with Rachel Slevinsky, #2 "Stud Muffin" ridden by Rafael Hernandez and #3 "Gargas" ridden by Leo Salles. #2 clipped the heels of #1 and rider Hernandez becomes unseated. Rachel said her horse broke well but spooked from something on the inside of the fence and went out into the horses outside me, I did the best I could to keep him in. Leo said the inside horses came out to him, had Rafael to my inside but not much I could do as I had a horse outside me. Rafael said the inside

horse came out into his path and caught that one's heels. After review, #1 was disqualified from third and placed last.
