**Race 1:** Breath test strip utilized.

Judges' Inquiry & Driver's Objection: Along the rail in deep stretch #4 Play Like Kiara (G.Rooney) attempts to move to the inside of #1 Pocket Monster (D. Rankin Jr.) who was also along the rail ahead of #4 Play Like Kiara. #4 Play Like Kiara then made a break before the finish and thru the wire. The driver's objection was disallowed and #4 Play Like Kiara finished 4<sup>th</sup> and was placed 6<sup>th</sup> for being double lapped while off stride at the finish. #2 Spare Time Serg (D. Clements) finished 5<sup>th</sup> and was placed 4<sup>th</sup>, and #6 Rocknroll Nation finished 6<sup>th</sup> and was placed 5<sup>th</sup>. Interference was given to #2 and #6.

No back tower video available.

**Race 2:** Clear.

**Race 3:** #5 Thebestneverreest (S.Wray) was inside two consecutive pylons around the last turn and finished 4<sup>th</sup> but was placed 5<sup>th</sup> as the horse was lapped on by #3 So You Say (M. Williams). #3 So You Say finished 5<sup>th</sup> and was placed 4<sup>th</sup>.

**Race 4:** #6 Crystal Dragon (D. Clements) finished 6<sup>th</sup> and was placed 8<sup>th</sup> for causing interference to #5 Howmac Sabrina (C. Johnston) at the head of the stretch. #5 Howmac Sabrina was charted with an interference break. No penalty was given to driver Clements as it was tight racing coming out of the turn.

Driver D.Clements was also cautioned about keeping his feet from contacting the horse when leaving the gate.
