- Inquiry #1 – Reviewed pylons on #4 Tymalpassuby (Tyler Moore) in the first turn, finished 1<sup>st</sup>. The low pan video showed that #4 was inside two consecutive pylons and hit two other pylons. #4 was lapped at the finish and therefore finished 1<sup>st</sup> placed 2<sup>nd</sup> for a pylon violation. No penalty to Moore as the horse is running in on the turn and he is attempting to correct her.

- Inquiry #2 – Reviewed the break by #1 Somethingaboutlucy (Brett Macdonald) before the start. The front tower video showed that #1 did not cause interference to #9 Tristar Dream (Braiden Reibeling) before the start; all horses received a fair start.

- #7 Delta Rose (Tyler Borth) finished distanced and must qualify for Performance, Tr. George Large.

Race 4 – All Clear

- #3 Power And Grace (Brett Macdonald) suffered broken equipment (shoe) after the start.

Race 5 – Reviewed pylons on #6 JKs Lifesaver (Travis Henry) past the half, finished 5<sup>th</sup> – horse was inside one pylon; no violations of the AGCO pylon rule.

Race 6 – All Clear

Race 7 – Reviewed the break by #1 Laugh Now (Colin Kelly) in the first quarter, finished 5<sup>th</sup> – no violations of the AGCO breaking regulations.

Race 8 – All Clear

Race 9 – Reviewed racing going to the 3/4s – #1 Bette Mittler (Nello Guglielmi) moves out and interferes with #5 JMR Sporty Mel (Colin Kelly). Mr. Guglielmi felt #3 Society Jill (Austin Sorrie) may have come out underneath him, but the video does not support this as it appears #3 has room to move out. #1 finished 7<sup>th</sup> placed 8<sup>th</sup> for interference; #5 was charted with an 'I'.

- Spoke to Ryan Desroche (#9 Larjon Lena) about the start and being gapped out from the trailer position. Mr. Desroche stated he was getting after her to get closer to the gate, but she does not like being in the second tier.
