Race 1: Clear

Race 2: Jockey Claim of foul. #2 Brady O'Brady (Salles) claimed foul on #1 Dotted Line (Mailhot) after the break. Video shows that #1 did break outwardly causing interference to both #2 and #3 Loquacious (Crawford). #1 finished 1st and was placed 4th behind #3. No penalty to rider, the horse was at fault.

Race 3: #4 Summer Retreat (Pinto) broke outwardly.

Race 4: Clear

Race 5: #1 Hermoine Granger (Mailhot) broke inwardly and just missed hitting the rail.

Race 6: Jockey Claim of foul by #2 Allaboutthedrama (Pinto) on #7 Lets Run Two (Slevinsky) around the last turn and in the stretch. Pinto claimed that Slevinsky came down in the turn and bumped her horses back end and then sawed her off in the stretch. Slevinsky said she was trying to keep horse out. #7 finished 3rd and was placed 3rd behind #2 for causing interference. Notice of review sent to Slevinsky for tomorrow.
