Race 2 Clear

Race 3 Inquiry in last turn. #2 TT Conway (McNair) was inside the pylon marking the start of the passing lane. #2 finished 1<sup>st</sup> and was placed 5<sup>th</sup> for gaining an advantage on #5 Casada. Also, #3 Arcanum (J. MacDonald) was also inside the same pylon. #3 finished 3<sup>rd</sup> placed 2<sup>nd</sup> (from the placing of #2), then placed 5<sup>th</sup> for gaining an advantage on both #5 and #2. #3 was then placed 5<sup>th</sup> behind #2. Agco rule 22.05.02.2 (iii).” Horses using the open stretch must first have complete clearance of the pylons.”
