- 1. Reviewed the performance of #2 MISTER DG (Doug Brown), who finished second. concerning leaving the course after the \(^3\)4 mile pole; #2 did go inside one pylon and struck the subsequent pylon; no violations. Clear.

The driver of #6 RAMBARON ROSE (John Thomson) suffered broken equipment (knee boot) after the start and finished with broken equipment. The driver of #6, Mr. Thomson, had an official warning entered on his licence concerning his urging in the stretch. Clear.
