Race 2 Inquiry at the start. #3 Unevergonnagethis (Stacey) made a break and was inside the fair start pole. Also reviewed the start by #5 Ima Stand-up Guy, the horse was rough but did not make a break. And also, the #1 Black Bomber (Jamieson) suffered an equipment break due to the Buxton Martingale being broken.

Inquiry in the stretch. #8 Urntrouble Hanover made a break, the horse finished 4<sup>th</sup> and was placed from 4<sup>th</sup> to 7<sup>th</sup> for failing to continuously lose ground while off stride.

Race 7 Inquiry at the start. #3 No Time At All had broken equipment before the start. The head check was off. Refund of \$8,685.

Race 8 Reviewed the break at the ½ by #7 Archimed Alpha, no violations. Also reviewed the head of the stretch, #8 HP Mighty Angus (Roy) did bear down inside the pylons in the stretch. #8 finished 8<sup>th</sup> and was placed 10<sup>th</sup> for being inside more than 3 consecutive pylons while on stride. Judges spoke to Roy who said the horse was bearing in, so he took him off the track for safety. The Trainer J. Tourigny will make the appropriate changes to help the horse.
