Doug McNair was excused from five drives this evening.

Races:

Race 1: Driver Bob McClure was found in violation of AGCO Rule 22.05.01(k), did fail to set a pace comparable to class while driving Codys Moment. The second quarter was 31:2. Monetary penalty of \$200. Ruling #2442483.

Race 2: Reviewed the break of #3 Franks Angel before the start. The horse was well inside the fair start pole.

Race 3: Clear.

Race 5: Clear.

Race 6: #3 Impressive Dude (L.P.Roy) finished 2nd by staying and advancing along the rail as #1 Rosies War Bonds (E.Hensley), finished 10th, tired and drifted out. No penalty to driver Hensley, as Roy tried to move off the rail as Hensley came out. Roy then went to the inside. #3 Impressive Dude would have gotten out behind first over #7 Morally Flexible at the head of the stretch and then would have returned to skim the pylons. The judges determined that the tiring #1 Rosies War Bonds did not change the order of finish by coming off the rail.

Race 7: #2 Miss Dew Write and #6 Fashion Forward finished 5th in a dead heat.

#2 Miss Dew Write (S.Filion), finished 5th dead heat, and #5 True That (Trev.Henry), finished 7th, come together in deep stretch. No placings needed.

Race 8: #2 Dowedealinandwhy finished with broken equipment. (two shoes)

Race 11: #5 Two Pistol Annie (L.P. Roy) beared off the rail in deep stretch but was under siege by the race winner, first over #1 Powder Play (J.Jamieson). Also, #5 was tiring and Roy attempted to keep his horse straight.
