James Macdonald was found in violation of AGCO Rule 22.05.01(k), failure to set a pace comparable to class while driving #6 Century Jamila. Fractions were 26:1, 57:1, 1:25:4, 1:53:1. \$200 monetary penalty. Ruling #2338782.

#1 Caughtyoupeaking pulled up after the half mile mark and did not finish, the horse must qualify for performance and was placed on the Long Term Vet's List for sickness by the Commission Veterinarian.
