Race 2:

- #2 Momsextravagantheart (Cassandra Jeschke), (finished 1st) and #3 Rowdy and Bodacious (Brian Bell), (finished 5th) both break inward at the start.
- The rest are clear.

Race 3:

- #3 Hanover Hill Same (Ten Harriott), (finished 5th) and #4 Postal Kode (Regan Knowles), (finished 7th) both broke late.
- The rest the clear.

Race 4:

- #1 Night Fishn (Josh Scott), (finished 3rd) stumbles badly on the break.
- Stewards inquiry, reviewed racing coming to the wire between #2 Selective Memory (Ed Walton), (finished 5th) and #1 Night Fishn (Josh Scott), (finished 3rd). #1 does come over towards #2 but the #2 was running out on his own and was not close enough. No changes.

- #3 Cc Senator Page (Helen Marie Vanek), (finished 1st) stumbles at the break.
- #7 Marianita (Cassandra Jeschke), (finished 3rd) breaks in the air.
- The rest are clear.

Race 6:

- Stewards Inquiry, reviewed the break by #3 Jess as Sweet as Me (Ed Walton), (finished 6th).

#3 was a complete pari-mutuel refund due to the fact that he had an unfair start due to being held in the gate. Refund amount \$1,746.

#5 breaks slowly and behind the #4. The #4 does come over towards #7 but the rider of the #7 (Brain Bell) says he was not bothered and the #4 outbreaks the #5.
Both claims of foul were disallowed by the Stewards.
