Office:

- Ruling #1069782 generated for Jockey Cory Spataro concerning an incident on September 2, 2020. Violation of AGCO rule 16.05 (a) & (b) (*disturbing the peace*). A monetary penalty of \$100.00 was assessed.
- Ruling #1069777 generated for Association Official Dr. Brett Anderson concerning an incident on September 2, 2020. Violation of AGCO rule 16.05 (a) & (b) (*disturbing the peace*). A monetary penalty of \$100.00 was assessed.
- Ruling #1069785 generated for Association Official Dr. Brett Anderson concerning an incident on September 2, 2020. Violation of AGCO rule 9.04.01 (*entering a restricted area without permission from the Stewards*). A monetary penalty of \$200.00 was assessed.
- Ajax Downs is testing camera drones today. The drones will be utilizing the area above the front tower only.
- Jockey Max Badal was excused from one ride today.
- Time checks complete.

Race 1:

- Prior to the race the Stewards received a phone call that #1 One Famous Glass (Trained by Bryn Robertson) was using a nebulizer on the backstretch. This is contrary to Thoroughbred Directive No.1 – 2019 (Standards-Based race day medication ban) and the horse was subsequently scratched by the Stewards. The Stewards will be holding a telephone review with Trainer Bryn Robertson next week.

Race 3:

- Prior to the race #5 Not Whistlin Dixie (Trained by Amanda McCormack) was listed as wearing blinkers in her last start, this was a program error as this horse wears a hood not blinkers. The error was announced to the public.

Race 4:

- #3 Rey of the Night (Cassandra Jeschke), (finished sixth) broke in the air.
- #7 Carlos the Second (Norman Lloyd DeSouza), (finished fourth) stumbles on the break.

Race 5:

- #2 Eye Got Yer Back (Cory Spataro), (finished sixth) broke slowly.

Race 6:

- #5 Dash for Goldilocks (Regan Knowles), (finished seventh) comes in to #4 Whisky James (Tony Phillips), (finished fourth) and turns the #4 outward. No placings required.
- Jockey Ed Walton (#6 Twixt Of Fate), (finished second) was found to be in violation of AGCO rule 9.27.07 (d) & (e) (*did use his crop in an overhand cocked position*). Mr. Walton is subject to a \$300 monetary penalty and one day riding suspension on September 21, 2020 (*second offence in a one-year period*). Ruling #1070826.

Race 7:

- Stewards inquiry reviewed the start concerning the #3 Countryfried Chicken (Helen Marie Vanek), (DNF). #3 turned his head to the right as the gate sprung. The Stewards determined that the #3 dwelt and did receive a fair start.

Race 8:

- Jockey Ismael Eluid Mosqueira (#5 This Chick Rules), (finished second) was found to be in violation of AGCO 9.27.07 (a) (*did raise his hand above his shoulder while using his crop*). Mr. Mosqueira is subject to a \$200 monetary penalty. Ruling #1070852

Race 9:

- Stewards inquiry on the break. #2 One Kool Dynasty (Helen Marie Vanek), (finished first) breaks outward towards #3 EC Greys Anatomy (Ed Walton), (finished third). #3 breaks in the air and inward as they come together. No violations.

Race 10:

- Reviewed racing coming to the wire. #2 Chalk Cliffs (Ed Walton), (finished seventh) comes out to #6 CC Senator Page (Ismael Eluid Mosquera), (finished fourth) and #7 Marianita CSJ (Cassandra Jeschke), (finished second). Jockey Ed Walton stated that his horse took a funny step and he had to correct him. No placings required.
