

Office:

- The Stewards held a review with Trainer Bryn Robertson concerning an incident in the receiving barn last week. The following rulings for Trainer Bryn Robertson were issued.

Generated ruling #1074760. AGCO rule 15.38 (a) & (f), 16.13 (d) & 24.04. (*Trainers shall ensure that a horse entered to race is not administered any medications, drugs, or substances 24 hours prior to post time of the first race on the day of racing*) & (A Steward may order the withdrawal of any horse).

The horse One Famous Glass was scratched by the Stewards for being administered saline solution via a nebulizer prior to race one on September 14,2020. Mr. Robertson was issued a \$200.00 monetary penalty.

Generated ruling #1073997. AGCO rule 15.38 (f). (A Steward may order the disqualification of any horse).

The horse Whisky James was disqualified by the Stewards for being administered saline solution via a nebulizer prior to race six on September 14,2020. A new order of finish has been issued.

Ruling number yet to be generated. AGCO rule 15.38 (a) & (f), 16.13 (d) & 24.04.

(Trainers shall ensure that a horse entered to race is not administered any medications, drugs, or substances 24 hours prior to post time of the first race on the day of racing).

The horse Whisky James was disqualified by the Stewards for being administered saline solution via a nebulizer prior to race six on September 14,2020.

Mr. Robertson was issued a \$200.00 monetary penalty, (Whisky James).

Ruling number yet to be generated. AGCO rules 15.09.01, 15.28, 16.13 (d) & 24.04. (for not complying with generally accepted standards) & (knowingly withholds information or misleads the Stewards).

Mr. Robertson was assessed a \$1000.00 monetary penalty.

- Jockey Regan Knowles was excused from his three rides today
- Time checks complete.

Race 1:

- Jockey Ramiro Sanchez Castillo (#2 Caraways Jet Moon), (finished fifth) was found to be in violation of AGCO rule 9.27.07 (d) & (e) (did use his crop in an overhand cocked position). Mr. Castillo is subject to a \$200 monetary penalty. Ruling number yet to be generated.

Stewards inquiry, reviewed racing coming to the wire. #4 Upandover (Ramiro Sanchez Catillo), (finished third) comes out towards #5 Hanover Hill Sam (Ten Harriott), (finished fourth) and put the #5 on the heels of #6 Shock The Clocker (Cassandra Jeschke), (finished second). #4 finished third and was placed fourth for coming out and causing interference to #5 while coming to the wire.

A virtual review has been planned for Ramiro Sanchez Castillo on September 28, 2020 to go over the film with us.

 the first few jumps comes across the path of #6 and impeded the progress of #6.
 #4 finished second and was placed sixth for causing interference to #6 after the break.
