- Today is the final day of the 2020 racing season here at Ajax Downs.
- The Stewards approved the following horses for Trainer Transfers, going from Trainer Jason Pascoe to Trainer Carol McIntyre.

- Jockey Max Badal was excused from his mounts today.
- A virtual film review was held with Jockey Cory Spataro concerning the first race last week. Mr. Spataro stated that his horse Hanover Hill Justin shied away from the infield jumbotron and into the path of Red N Wild Signature. Hanover Hill Justin is a two-year-old

and Mr. Spataro did try to correct the horse despite the horse's behaviour. No penalty is required.

- A virtual film review was held with Jockey Norman Lloyd DeSouza concerning the fifth race last week. Mr. DeSouza does come down with his horse Phil Jefferson and interferes with Ms Mexican Mouse. Mr. DeSouza was assessed a one-day riding suspension to be served on May 16, 2021. Ruling #1095317
- A virtual film review was held with Jockey Tony Phillips concerning the fifth race last week.
 Mr. Phillips does go out with his mount Caraways Jet Moon and interferes with Ms
 Mexican Mouse. Mr. Phillips was assessed a one-day riding suspension to be served on May 16, 2021. Ruling #1095398
- A virtual film review was held with Jockey Tony Phillips concerning the seventh race last week. Mr. Phillips stated that his horse Bogie Wheels broke sharply from the gate and directly to the right interfering with All Outta Sugar to his outside. Mr. Phillips said the filly is a two-year-old and he tried to correct the horse but there was nothing he could do. No penalty is required.
- Time checks complete.

Race 1:

- #2 Red Wagon Dust (Tony Phillips), (finished first) broke in the air.
- Cautioned Jockey Ten Harriott (#1 Hanover Hill Sam), (finished fourth) about getting his hand above his shoulder while urging.

Race 2:

- All clear.

Race 3:

- #4 Me Zoomn By (Brian Bell), (finished fifth) was away slowly.

Race 4:

- Stewards inquiry. Reviewed the break by #5 Bewitchin (Cory Spataro), (finished fourth). The Assistant Starter does not release the horse when the doors open. #5 was deemed to have not received a fair start and was a complete parimutuel refund.
- The Stewards also reviewed the break between #1 Postal Kode (Regan Knowles), (finsihed sixth, placed seventh) and #2 Unceremoniously (Brian Bell), (finished seventh, placed sixth). #1 goes out to #2 on the break and interferes with #2. #1 finished sixth and was placed seventh for causing interference to #2.

- #1 Bending Over was a late scratch by the Commission Veterinarian during the post parade.
- All clear.

Race 6:

 The Stewards reviewed racing concerning #3 CC Senator Page (Helen Marie Vanek), (finished sixth). Ms. Vanek stated that the filly is nervous and shies away from other horses when they get in close to her.

Race 7:

- All clear.

Race 8:

- #6 Carlos The Second (Norman Lloyd DeSouza), (finished ninth) was away slow.

Race 9:

Inquiry, Jockeys claim of foul #9 Hanover Hill Chalsee (Ed Walton), (finished seventh) on #10 Down In Carolina (Ismael Eluid Mosqueira), (finished third).
 #9 is between horses and goes down to #6 Pretty Runaway (Tony Phillips), (finished fifth) then comes out to #10 as #10 is going in towards #9. #10 was always clear of #9. Jockey claim of foul was disallowed.
