#### Race 2:

- #3 Chiseled Man (Helen Vanek), (finished fourth) was erratic. The Stewards spoke to Jockey Helen Vanek who stated that the horse did not like the dirt kicking back in his face.

#### Race 3:

- #4 Seismick (Helen Vanek), (finished fifth) was away slowly.

## Race 4:

The Stewards reviewed the start between the #2 Stanair (Norm DeSouza), (finished sixth placed fifth) and #3 Heza Majestic Hero (Helen Vanek), (finished fifth placed sixth). #2 and #3 break together out of the gate as the #3 takes the #2 down to the one path. #3 finished fifth and was placed sixth for causing interference to #2 on the break.

The Stewards spoke to Jockey Helen Vanek. Ms. Vanek stated that the horse is a two-year-old and turned left leaving the gate. There is no penalty to Ms. Vanek.

#### Race 5:

- Stewards' inquiry, Trainer and Jockeys claim of foul #5 Bewitchin (Cheyenne Kerr), (finished sixth) on #6 Kitsawinner (Norman DeSouza), (finished third). #6 is coming in as the #5 is coming out. The Trainer and Jockey claim of foul was disallowed.
