Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Early vet scratch (sick) of UNCLE BILL from the third race by the trainer.
- Early vet scratch (lame) of BLISSFULL FACTOR from the eighth race by the trainer.
- Early Judges scratch (injured) of DABUNKA from the twelfth race by Dr. J.D. Adam.
- Luc Loyer did fail to comply with HRAP decision 050472020 (22 September 2020) upholding the disqualification of BRIGADIER BRONSKI A (owned & trained by Luc Loyer) from race 7 on 22 September 2019, ordering all purse monies, driver fees and trainer fees to be returned within 15 days. On 6 December the Judges directed Mr. Loyer to return these monies to the Association bookkeeper at Woodbine for redistribution by 11 December 2020. As these monies have not been received, Mr. Loyer may race horses entered this evening and is fully suspended beginning 14 December until these purse monies and fees have been deposited with the Association (AGCO rules 18.08.01 (purse monies must be returned within 15 days), 5.11 (failure to follow direction of the Judges), 6.20(b) (misconduct prejudicial to the best interests of racing) and 6.01(c) (suspension may be imposed)) (Number: 1122756).
- Virtual review held with driver Pierre Bovay regarding race 7 on 29 November while driving HAT TRICK MARLEAU. Mr. Bovay was adjudged guilty of violating AGCO rule 22.05.01(a) (bear down causing interference) and was assessed a driving suspension of three days (23, 26 & 27 December, inclusive) (Number: 1122725).
- Virtual review held with driver Tyler Jones regarding race 10 on 6 December while driving GENESEE. Mr. Jones was adjudged guilty of violating AGCO rule 22.23.03(b) (more than acceptable wrist action) and was assessed a driving suspension of three

days (23, 26 & 27 December, inclusive) and a monetary penalty of \$200 (Number: 1122741).

1. Due to an equipment malfunction the electronic photo finish was unavailable; Judges decision final was announced to the public. Clear.

No penalty to Mr. Jones as his horse was visibly bearing in.
