Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Early Veterinarians scratch (sick) of JON SNOW from the sixth race; this horse is entered on the short term (seven days) veterinarians list.
- Early Judges scratch (transportation) of HOWMACFEISTY from the first race.
- Virtual review held with trainer Emily Vienot concerning the performance of the race winner DE CHAIRMAN in the tenth race on 11 August. The explanation of Ms. Vienot (horse in a lower class, new driver and race went entirely in the horse's favour) was accepted and no regulatory action is required.

Races:

- No video review available for the first two races due to connectivity issues.
- Clear.
- Late Veterinary scratch (sick) of MIDNIGHT MATTY; this horse is entered on the short term (seven) days veterinarians list; refund: \$141. Recall as the #2 HOWMAC VICTOR (Jimmy Gagnon) broke before the start causing interference to #9 SPEAK OF WAR (Guy Gagnon). Clear.
- 3. Reviewed the break by #3 DREAMFAIR TECATE (Marie-Claude Auger) after the ¼ mile pole, pulled up and did not finish and must qualify (trainer notified); while off stride #3 did cause interference to #1 THANKYAVERYMUCH (Jimmy Gagnon), #4 MATTS

TUITION (Guy Gagnon) and #9 EATAAMS SPORTSBABY (Stephane Brosseau); no placing necessary.

DREAMFAIR TECATE was examined by the AGCO Veterinarian, Dr. Melissa Rocheleau, post race and placed on the long term veterinary list due to lameness and must qualify. Clear.

- 5. Reviewed the performance of #4 ON CRUISE CONTROL (Ryan Guy) around the last turn concerning possibly leaving the course; #4 did contact one pylon, go inside the subsequent pylon and contact the next pylon; no advantage gained and no violations.

Inquiry concerning possible interference when #6 LORD AND LEGEND (Mike Healey) and #8 ROAD RUNNER COLONY (Guy Gagnon) hooked wheels before the ½ mile pole; after reviewing the video it was determined that the interference was caused by #6 bearing out into the path of #8 then coming down into #3 DARCEE N (Emil Toth); both #3 and #8 were charted with interference; no placing necessary as #6 finished eighth (last); no penalty to Mr. Healey as #8 was visibly bearing in and out; the trainer (Mike Healey) will make equipment adjustments to correct this problem. Clear.
