- Following on the dismissal by HRAP of the appeal by Tyler Jones of ruling SB 1106315 imposing a driving suspension of three (3) days for violating AGCO rule 22.05.01(h) (strike or hook wheels with another sulky) while driving PANTHEON SEELSTER in the fifth race at Rideau Carleton Raceway on 5 November 2020, the penalty is reinstated. Mr. Jones shall serve a driving suspension of three (3) days (16-18 February, inclusive) (Number 1154524).
- Five weather scratches this evening.
- Early Judges scratch (ineligible) of PLAYIN FOR KEEPS from the third race (AGCO rule 22.34 Coggins test invalid).
- The following horses have been entered on the EIPH program and did receive Lasix prior to racing: SOS JUSTIFIED in the first race, SANTANNA TONY in the fourth race, and SHADOW MARGEAUX in the thirteenth race: announced to the public.
- Following on the dismissal by HRAP of the appeal by Guy Gagnon of ruling SB 1108800 imposing a driving suspension of ten (10) days and a monetary penalty of \$300 for violating AGCO rules 22.23.01(c) (aggressive urging) and 22.23.03(e) (welt a horse), and considering Policy Directive 5-2009 prescribing penalty, while driving SOS JUSTIFIED in the third race at Rideau Carleton Raceway on 20 August 2020, the penalty is reinstated. Mr. Gagnon shall serve a driving suspension of ten (10) days (22 February to 3 March 2021, inclusive) and receive a monetary penalty of \$300 (Number 1156370).
