Report on day's events:

4. Recall as #1 MIDNIGHT MOOD (Jimmy Gagnon) had broken equipment (overcheck) which was fixed; when the horse returned to the track the line ring broke necessitating return to the paddock. Reviewed the performance of #2 SILVERADO (Ryan Guy), who finished third, around the last turn; #2 did go inside two non-consecutive pylons; no violation of the inner rail rules. Clear.

5. Driver of #4 DR JOE, James Bailey, was adjudged guilty of violating AGCO rules 22.23.02(b) (horse not in contention) and 22.23.03(b) (more than acceptable wrist action) regarding his urging after the ¾ mile pole and was assessed a driving suspension of three days (26-28 October, inclusive) and a monetary penalty of \$200

(Number 1922939); #4 broke before and after the start and before the $\frac{3}{4}$ mile pole and qualifies for breaks in two consecutive races on a fast track (trainer notified). Clear.

6. Reviewed the performance of #1 STAR DOG (Ryan Guy), who finished second, before the $\frac{1}{4}$ mile pole; #1 did contact one pylon, go inside the subsequent pylon, and contact the next two pylons; no violation of the inner rail rules. Discussed keeping clear of the pylons with Mr. Guy. Clear.
