- Driver Guy Gagnon was adjudged guilty of violating AGCO rules 22.23.01(c)
  (aggressive action) and 22.23.03(e) (welt a horse) concerning SOS JUSTIFIED in the
  third race on 20 August. Mr. Gagnon was assessed a monetary penalty of \$300 and a
  driving suspension of ten (10) days (19-28 October, inclusive) per Policy Directive No.
  5-2009 (Number 1078800).
