### Report on day's events:

### Office:

- Ontario Sires Stakes for three year old filly pacers; one Prospect, two Grassroots and two Gold divisions.
- Review held with driver Jimmy Gagnon by Starter Jamie Fiolek concerning CROSSFIT scoring ahead of the starting gate in the ninth race on 25 August before the starter had released the field and causing a recall in this race. Mr. Gagnon was deemed in violation of AGCO rule 22.03(j)(iii) and assessed a monetary penalty of \$100 (Number 1849768).
- Early Judges scratch (ineligible) of QUIVERS HANOVER from the third race (AGCO rule 11.02.01).

5. Start delayed as the #6 TWIN B LAKER (Guy Gagnon) would not turn. Reviewed racing in the stretch between #1 PERPETUAL ROCK (Ryan Guy), who finished third, and #3 HES GOT A VENDETTA (James MacDonald), who finished second; #1 did bear out but did not impede the progress of #3; no violations. Clear.

6. Driver of #6 SHANGHAI SEELSTER, Jonathan Drury, will attend a review regarding his urging in the stretch. Clear.

11. Reviewed the performance of #1 ROCK N ZEUS (Jody Jamieson), who broke before and after the ¼ mile pole and was off stride for more than 25 consecutive strides; #1 finished eighth placed ninth (last) (AGCO rule 22.27.02) for an extended break; while off stride #1 did cause interference to the place finisher, #9 GETYOURLICENSELIAM (Guy Gagnon). Clear.
12. Reviewed the performance of #1 ON CRUISE CONTROL (Ryan Guy), who finished seventh, around the last turn concerning leaving the course; #1 did strike one pylon, go inside two consecutive pylons, strike the next pylon and was double lapped on; #1 finished seventh placed ninth for leaving the course (AGCO rule 18.08.02(a)); no penalty to Mr. Guy as racing was tight around the turn.  
  
Reviewed the break by #3 SELF ISOLATION (Austin Sorrie) after the start; while of stride #3 did cause interference to #5 DARCEE N (Emil Toth); no placing necessary as #3 finished posterior to #5. Clear.
13. Late Veterinary scratch (sick) of STONEBRIDGE HERMES by the AGCO veterinarian, Dr. Melissa Rocheleau; this horse is entered on the short term (seven days) veterinarians list; refund: \$76.  
  
Recall as #1 TIME TO DANCING (Stephane Pouliot) broke before the starter released the field causing interference to #9 MASTER FENCER (Austin Sorrie). Clear.
