Report on day's events:

Office:

- Race Official Sharla Coles attended the interim paddock this evening.

Races:

1. The #7 FRIAR VOLTAIRE (Pascal Berube) suffered broken equipment (hobble and shoe) before the ¾ mile pole and subsequently broke (charted with an equipment break) and finished with broken equipment. Clear.
2. Clear.
3. Inquiry and driver's objection by #1 LACHLANON THE BEACH (Jimmy Gagnon) against #2 GRITTY (Jacques Beaudoin) after the start; Mr. Gagnon stated that #2 did bear down forcing him into the pylons; Mr. Beaudoin stated he was crowded; objection upheld; #2 finished second placed third for causing interference to #1 (AGCO rule 22.09).

Jacques Beaudoin will attend the judge's office to review the race video per AGCO rule 22.05.01(a) (bear in causing interference). Clear.

4. The #3 DIAMOND ROCK (Drew Smyth) suffered broken equipment (buxton) before the ½ mile pole and finished distanced with broken equipment; post race this horse was examined by the AGCO veterinarian, Dr. Melissa Rocheleau, and placed on the long term (14 day) veterinarians list (sick) and must qualify.

#5 NC ROCKABYE (Robert Shepherd) broke after the start and did cause interference to #6 SPORTS ICON (Guy Gagnon) and #8 JON SNOW (Pascal Berube) while off stride; no placing necessary as #5 finished posterior to the interfered with horses. Clear.

6. Driver of #7 PERPETUAL ROCK, Pascal Berube, was cautioned regarding his urging in the stretch. Clear.

8. Recall as #3 PANTHEON SEELSTER (Jimmy Gagnon) had broken equipment (overcheck). The #8 KWIK TALKING (Gordon Ley) was examined by the AGCO veterinarian post race and placed on the short term (7 days) veterinarians list. Clear.
9. Inquiry and driver's objection by #6 MAKE IT COME TRUE (Guy Gagnon) on #1 DAY DELIGHT (Jimmy Gagnon) at the top of the stretch; Mr. Guy Gagnon stated that #1 hit and flattened his tire at the top of the stretch (verified by Starter Jamie Fiolek); Mr. Jimmy Gagnon stated that #6 stopped suddenly causing his horse to contact the wheel; objection upheld; #1 finished third placed fourth for causing interference (AGCO rule 22.09).
