Backstretch:

Extreme heat standards implemented today.

1 scratch submitted for heat, is excused

Call to Owner/Trainer Tedston Holder regarding the horse Wicked Miah, entered into the 7th race Sunday August 22, 2021. Horse appears to have been entered while on the Veterinarian list in the State of Florida. Has run here twice previously. Discussion revolved around previous trainers in Florida. Suspended trainer George Navarro was listed as the trainer of record in Florida, the horse never started and all horses listed of Navarro's were entered onto the Vet's list. We felt that this situation did not warrant a scratch of the horse due to exceptional circumstances.

Review with Trainer Sylvain Pion, Inspection #1286747, fail to provide medical records pertaining to the horses he trains. Is a violation of AGCO TB rule 15.09.01 (f). issued a monetary penalty in the amount of \$300.00.Ruling to be issued

Film Reviews:

Race 4, August 19, 2021, Sahin Civaci, Luis Contreras, I. Driedger as rep. Mr. Civaci did come in when not clear and interfered with the inside horse ridden by L. Contreras. Mr. Civaci issued a three day riding suspension. Days to be determined.

Race 1, All clear

Race 2, #6 One Thou bore out at start, Jockey claim of foul, #5, A. Santos, 3rd on #9 C. Husbands, 2nd, through the stretch. Upon review of front tower and upper pan camera angles of the stretch run, #5 is inside of #9 and #9 is laying in slightly as #5 does come out a couple of times. The incidental contact did not warrant a placing. Claim of foul disallowed. Inquiry video: https://youtu.be/zj3feK67YVs

Race 3, #6 Where's My Halter bore out at start, rest ok.

Race 4, #7 Forester's Destiny was loose on the track on the way to paddock and was subsequently scratched by the Stewards.

Race 5, Inner Turf, All clear

Race 6, Slight delay, 12 minutes, #1 Ikerrin Road lost a shoe behind the gate prior to being entered into its stall, returned to paddock area and reshod, race All clear

Race 7, Inner Turf, Stewards Inquiry regarding run into the far turn with #1, S. Bahen 3rd, and #2 E. Wilson, 6th, Upon review of back tower, upper pan and apex camera angles, #1 does have trouble negotiating the turn and does go out to #2 and #2 out to #6. After speaking with the riders involved and review of film it was determined #1 caused interference and was disqualified from 3rd position and placed 6th.
