Call from race office, issue with eligibility of the horse, Hyperfocus, Race 5, was claimed on the 22nd of July 2022. Steward scratch, ineligible as per TB Rule 12.07, must be 30 clear days from date of claim.

Jockeys Flavien Prat and Vincent Cheminaud were tutored on the urging policy here in Ontario.

Jockey James Chau excused from his mount today.

A decision was made at approximately 8;00 AM by the Association to remove Race 13, from the EPT Turf due to impending rain forecasted and a policy of WEG.

Race 10, August 21, 2022, Juan Crawford and Justin Stein. D. Gomez as rep. #5 J. Crawford does move laterally left after the start into the path of #4 J. Stein when not clear. #4 does catch a heel of #5 and stumbles. No placings were necessary as #4 did finish 1st ahead of #5 which was third. The inquiry video was not posted last night for that reason. It is here to review. Mr. Crawford issued a three-day riding suspension. Days to be determined.
