#### Film Reviews:

Race 6, December 3, 2021. #4, K. Nicholls and #2 J. Hoyte, #4 does move laterally left into the path of #2 deep stretch, #4 was 3<sup>rd</sup> placed 7<sup>th</sup>. K. Nicholls issued a three-day riding suspension TB Ruling #1545723, first three days of the 2022 racing season at Woodbine.

Race 1, #2 Vermont Holiday stumbled at the start, rest ok

Race 2, All clear

Race 3, #3 Ignited and #5 Maakwa both stumbled first jump, #5 Maakwa prevailed, reviewed run

through the finish as #4 Wave Baby does move laterally right to the #3 Ignited's path. Is through the finish, no placings required. Spoke with jockey Juan Crawford to be aware of changing lanes when urging and not clear.

Race 4, #2 Suitedconnected reared badly at start, lost a lot of ground, did receive a fair start, rest ok

Race 5, Reviewed run at the top of the stretch with #4 Bocelli, S. Civaci, 10<sup>th</sup>, and #12 Karakontie Pat, J. Stein, 8<sup>th</sup>, film inconclusive, no placings necessary. Rest ok

Race 6, #10 Collaborative reared in the gate and on advisement of the veterinarian, was a scratch (. Horses were backed out and reset prior to the start. #1 Pot Committed broke slow and trailed throughout, rest ok.

Race 8, Jockey claim of foul, #10, K. Nicholls, 7<sup>th</sup>, on #3, R. Hernandez, 4<sup>th</sup>, stretch run around the 1/8<sup>th</sup> pole. Upon review of the upper pan and front tower camera angles, #3 is going out to where the #10 has its path, #10 checks a stride but does not warrant a placing. Claim of foul disallowed.
