

Hernandez impeded her path and her horse switched leads and went into the #1. R. Hernandez explained that he had ridden the horse previously and asked the trainer to make an equipment change, adding blinkers. When he broke from the gate he seemed to wander down to the inside, grabbed a hold but damage was done. We felt the issue was a horse error and no action taken on R. Hernandez.
