Race 3, #8 Stowaway, D. Fukumoto, 4<sup>th,</sup> moved inside making it tight for eventual winner #7 Midnight in Malibu after the start, #7 steadied but prevailed. Spoke with Fukumoto to ensure he is clear when moving laterally. Rest good
