Race 1, All clear

Race 2, #1 Painting the Moon was loose after coming onto the track, ran off to the backstretch and was subsequently a Steward scratch. (Refund \$35,806) Stewards Inquiry and Jockey claim of foul, #4, Steve Jadoo, 5th on #6 K. Nicholls, 1^{st,} mid stretch. Upon review of the front tower and upper pan camera angles, #6 does come in when not clear as #4 has to check hard, we also looked at the #2 horse taking a step out but felt the #6 to be the major contributor prior to #2 making the step out. #6 finished 1st placed 5th.

Race 3, #2 Framed stumbled at start, Jockey P. Husbands lost outside stirrup, quickly recovered and finished race. #1 Mucho Man, off slow and trailed throughout. Rest good

Race 4, #1 Conditional off a step slow an #7 Rat Portage hesitated start. Rest good

Race 5, All clear. Spoke with jockey P. Husbands about no use of the crop with his horse Swot Analysis, 2nd. He explained that this horse lugs in so bad when you hit him he will hit the rail, just leave him alone and runs straight. Has done it previously.

Race 6, Inner Turf, #9 bore out slightly at start, prevailed, rest ok

Race 7, Stella Artois Fury Stakes, tight quarters inside for #3 Souper Flashy, A. Gallardo, 4th #4 Mommasgottarun, L. Contreras, 7th checked as #3 moves inward but appears clear. Rest ok

Following the 7th race, it was brought to the attention of the Stewards that the starting gate on the inner turf for race 6, may have set in the wrong position. After review of the positioning of the gate it was determined the gate had been positioned for a start of Lane 4, we were currently in lane 3 for todays races. The Stewards contacted the starter who believed we were in lane 4, today. Corrections were made and the starting was set in the correct position for race 8. The running time was correct as the G Max timing system reverts to a 203 ft run up to the start.

Race 8, Inner Turf, #1, Luz de la Luna bore in at start, rest ok.

Race 9, EPT Turf, All clear, hand time recorded of 1:34.13.

Race 10, All clear.
