

Race 1, 2-year-old race, No show, superfecta or triactor wagering due to 4 horse field, Race all clear

Race 2, #4 Get My Drift bore out slightly at start, rest ok

Race 3, 2-year-old race, #6 Winterberry unruly on the way out to the racecourse, did rear on the path and subsequently advised by the Official Veterinarian to be scratched. Refund of (\$14,647). #1 Sol de Verano, bore in, slight stumble at start, #2 Admiral Nelson bore out at start. Rest ok.

Race 4, All clear

Race 5, #2 Oh Peanuts reared in the starting gate prior to the start and on advisement of Official Veterinarian was scratched. Refund of (\$14,966). #8 Myra's Boy, popped up at start. Rest ok.

Race 6, All clear, spoke with Jockey Daisuke Fukumoto regarding his horse #10, Flawless Ruler, it appeared Mr. Fukumoto was easing his horse up mid far turn. Mr. Fukumoto stated his horse was lugging out and he couldn't steer him correctly but after they straightened out into the stretch, he was able to encourage the horse forward again. We accepted his explanation and no further action required.

Race 7, #1 Coprolite was eased through stretch, reviewed stretch run with #4, Jessamine Hill, S. Civaci, Dead heat for 3rd and #5 Bourbon North, D. Moran, 7th. Upon review #5 is lugging in and does drop in to the rail where #4 must steady. No violations and placings required. S. Civaci cited for failing to ride through finish, review on Friday.

Race 8, Jockey claim of foul, #4 S, Civaci, 3rd, wished us to review the run after the start, felt he was interfered with from outside horses, after review with the upper pan and back tower camera angles, #4 does steady as #5 was shying from outside horses and #3 may have pushed out from the inside. Both of those horses did finish in behind #4 and no placings were necessary, and the claim of foul was disallowed. Rest ok.

Race 9, Stewards' inquiry, stretch run, regarding #2 Chancel Juan Crawford, 5th, Upon review of upper pan and front tower camera angles, Mr. Crawford is steadying his mount but there is always room for his horse in between #7 and #4. No changes made to the order. #6 Maximus Momentus had a rough start and prevailed. Rest ok.
