Race 7, November 18, 2022. Juan Crawford, D. Gomez as rep. Raising hand above head level when making contact with mount. Issued a monetary penalty of \$400.00, 20% of earnings in a race with a purse of \$100,000. or over. TB Ruling #1956804.

Race 1, All clear

Race 2, #2 Upstart Gentleman off a step slow and eased through stretch, spoke with Jockey Eswan Flores who stated the horse was uncomfortable around the turn. Rest ok.

Race 3, Inquiry 1, Stewards, 1st turn, #9, K. Nicholls, 2nd and #4, K. Kimura 9th. Upon review of front tower and upper pan camera angles #9 is not clear as he moves to the inside forcing #4 to check off the #3, J. Hoyte on the rail causing a chain reaction. #9 was 2nd and placed 9th for interference. NOR for K. Nicholls, K. Kimura and J. Hoyte

Inquiry 2, Jockey claim of foul #8 J. Crawford, 3rd, on #9, K. Nicholls, 2nd and #2 S Civaci, 1st during the stretch run. Upon review of front tower and upper pan camera angles, #9 does come out slightly but has already been placed for the first infraction and the claim of foul was disallowed. #2, Sahin Sivaci, 1st, appeared to have stayed straight.

Race 4, #7Lady Xi off a step slow

Race 5, 15 minute delay to the start, the Paddock Judge relayed to the Stewards that #5 Jockey E. Flores was wearing charged heated gloves, the Stewards relayed to the starter that Mr. Flores would not be permitted to ride with the gloves in a race, Mr. Flores refused to ride the horse and it was returned to the paddock and D. Fukumoto was secured as a rider. #6 Indiana Road and #5 What's My Name were both slow from the start, rest ok

Race 7, All clear

Race 8, All clear, Malfunction of the photo-finish camera which led to the Stewards to manually decide the order of finish.

Race 9 reviewed run around far turn regarding #3 Billyjane 4th on the rail and #4 Ima Beast 1st, film inconclusive of any interference, #3 does appear to steady after #4 goes by outside. Rest ok

Race 10, #1 It Worked off a step slow, prevailed, rest ok
