Jockey Jeffery Alderson excused from his mount in the 10th race today.

Races slated for the EPT Turf have been removed and will run on the Main course, Tapeta, at their respective distances. Race 1 will not be run at an about distance, will be 1 mile and 1 eighth.

Jockey Robert Havlin, race 9, Durham Cup, tutored on the urging policy here in Ontario. Has not ridden here in approximately 10 years.

At 14:15, Woodbine removed the 8<sup>th</sup> race from the inner turf, will be run at a distance of 7 furlongs on the main, Tapeta, course.

### Film Reviews:

Race 1, October 6, 2023. Jockeys Eswan Flores and Christopher Husbands.E. Wilson as rep. Mr. Flores did come in with his mount approaching the far turn and interfere with the inside horse with C. Husbands.

Mr. Flores assessed a three-racing day suspension. Days to be determined. Was informed.

Race 2, #9 Forester's Turn bore out at start, prevailed, #8 Rockstar Ro bobbled start. Rest ok

Race 3, #4 Painted Glory in tight after the start and taken in hand, rest good.

Race 4, On advisement of the Official Veterinarian, #4 Shaystown and #5 Standing Strong were both scratched as the #5 reared in the gate and interfered with the #4 while in the gate. Total refund of \$103,040. #11 Gavel Girl lugged out badly down the backstretch and into the far turn, Jockey D. Fukumoto did pull the horse up to a gallop on the far turn, did finish the race. Stewards' inquiry and Jockey claim of foul #3, E. Wilson, 6<sup>th</sup> and #2, Leo Salles, 4<sup>th</sup>, inside the 1/8 pole marker, upon review #2 does go out and make contact with #3 forcing Wilson to steady her mount and lose momentum. #2 Tapping a Rhythm, finished 4<sup>th</sup> and subsequently placed 6<sup>th</sup>.
