

Race 8, The Natalma Stakes, September 16, 2023. E. Wilson and D. Carroll. E. Wilson, aboard #3, does go out and interfere with outside horses during the stretch run. E. Wilson did angle the horse out for clear running room but was not clear of the outside horses when doing so. Issued a three-day riding suspension. Days to be determined.

Race 7, The Vigil Stakes, September 16, 2023. Eswan Flores, urging through stretch. It was determined that Mr. Flores did break up the number of times he made contact with the horse with his crop within the rules. No penalty assessed

Race 1, **Stewards' Inquiry and Jockey claim of foul.** #7 on #5. #5 Desean Bynoe, 3rd, and #7, S. Chernetz, 4th stretch run. Upon review of upper pan and front tower camera angles, #5 does veer out into the path of #7 forcing Chernetz to check and lose momentum. #5 finished 3rd and subsequently placed 4th. Notice of review for Bynoe and Chernetz.

Race 2, EPT Turf, #3 Proud Ronin off a step slow and #5 Jaggersgotagun hit side of gate stall doors at start. Rest ok.

Race 3, **Stewards Inquiry**, #4 Sovereign Cause at the start, upon review of the back tower and upper pan camera angles, and speaking with Jockey Kazushi Kimura, #4 is fractious prior to the Starter releasing the field and is caught flat footed as it was throwing its head up. No interference from the starter or any malfunction of the starting gate, therefore deemed to have received a fair start and no refund ordered.

Jockey claim of foul. #1 K. Nicholls, 2nd on #2, R. Walcott, 1st, top of stretch, upon review of the front tower and upper pan camera angles, the interference was from the #6, which faded to fourth. Jockey claim of foul disallowed.
