Trainer Richard Davis, horse Strong Ending, left test barn prior to urine sample being obtained on September 13, 2022. Report from test barn stated the groom misunderstood direction after blood sample obtained. No action taken on Davis, purse account 1<sup>st</sup> place earnings for the 10<sup>th</sup> race was held and now released.

Trainer Desmond Maynard attended, informed of the process going forward. He was provided with the documentation required.

Jockey Isabella Wenc excused from her mounts today.
