**Race 3 – Clear - #3 "Peter Crown"** placed on the Judges List for "coggins" (Trainer Steve Watson). #2 "Letstaketoesky" finished with broken equipment (lost shoe).

**Race 5 – Clear.** #7 "Diamond Rock" (Moore 4<sup>th</sup>) finished with broken equipment (martingale).

**Race 6 – "Inquiry"** in the stretch #4 "Mach My Kiss" (Cullen 3<sup>rd</sup>) makes a brief break in stride, no violations of the breaking rule. No change. <https://youtu.be/ldhe-FkOkWg>

**Race 7 – Clear**

**Race 8 – “Inquiry”** Before the start, both #4 “Hershey Seelster” (MacDonald 5<sup>th</sup>) and #3 “Angelwithattitude” (Ryan 6<sup>th</sup>) make a break in stride, both on their own, no interference. Reviewed the number of strides the #4 was offstride, counting from the start line the horse was offstride for 15 strides and then went out of video view, was back on stride shortly after when back in view. No violation of the extended break rule.
