#### Office:

Ruling #2437984 generated – Resulting from positive analysis's for a class 4 drug - Horseperson Stephen Bossence has agreed to a settlement offer regarding violation of AGCO rules 9.09(b) 26.02.01, 26.02.02 and 26.02.03(c). Mr. Bossence is hereby assessed a \$500.00 monetary penalty, a 5-day full suspension, Nov 28,29,30, Dec 1,2, 2023, and must complete the AGCO Medication Use and Awareness Course.

In accordance with AGCO rules 9.13 and 18.08.01 "The Boss Man" has been declared "disqualified" from race #3 on October 17, 2023 at Western Fair.

In accordance with AGCO rules 9.13 and 18.08.01 "R J Hooker" has been declared "disqualified" from race #4 on October 17, 2023 at Western Fair.

Ruling #2438647 generated – Driver Donald Rankin did use more than acceptable wrist action while urging "Dazzlin Rosie" in the race 4, November 20, 2023. Mr. Rankin issued a \$300.00 monetary penalty and a 5-day driving suspension Nov 29,30, Dec 1,2,3, 2023. AGCO 22.23.03(b), 22.23.05(a,b). (second offence within a 12-month period).
