IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015. S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF Wayne S MACLEAN

On September 20, 2021, the Alcohol and Gaming Commission of Ontario "AGCO" was advised of a positive reading for the Class 2 drugs ephedrine, phenylpropanolamine, pyrilamine and its metabolite O-desmethylpyrilamine, for the urine sample Test Tag 33 21247 002. The sample was obtained from the Standardbred Horse, "SUNNY SICILY", (tattoo #3RN23), which finished first (1st), in the first (1st) race on September 4, 2021 at Flamboro Downs Raceway. SUNNY SICILY was trained by Wayne Maclean, "MACLEAN".

TAKE NOTICE that based on the above MACLEAN is found to have violated 9.09(b), 26.02.01, 26.02.02 and 26.02.03(c) of the Rules of Standardbred Racing. In accordance with 6.01, 6.04, 9.08.02 of the Rules of Standardbred Racing and Policy Directive 1-2018, MACLEAN is hereby fully suspended for THIRTY DAYS (30) (December 9, 2021 to January 10, 2022, inclusive) and issued a monetary penalty of ONE THOUSAND FIVE HUNDRED (\$1,500.00) dollars. Consistent with past precedent, ephedrine is treated as a Class 3 substance

The suspension of MACLEAN is effective for horses racing in the Province of Ontario. During the suspension, MACLEAN is denied access to Association grounds with the exception of grandstand privileges. During the suspension, any horses owned in whole or in part by MACLEAN, are ineligible to race. Sales or transfers must be met with the Judges' approval. Horses trained by MACLEAN may be transferred to another trainer in good standing and in accordance with Policy Directive No. 2-2008.

In accordance with 18.08.03 of the Rules of Standardbred Racing, SUNNY SICILY is hereby declared disqualified for all purposes with the exception of Pari-Mutuel Wagering and all purse monies must be returned. The revised order of finish for Race 1, at Flamboro Downs Raceway on September 4, 2021 is as follows:

1st Carnival Heart #3 2nd Happy Looker

3rd #6 Havana Panic 4th #1 Viva La Deo 5th #7 Turning the Table 6th #2 Perfect Romi

#4 Sunny Sicily – disqualified

The following terms are added to MACLEAN's license: two years probation commencing (January 11, 2022 to January 10, 2024, inclusive), pursuant to 6.01(d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008:

- 1. The Licensee is required to complete the AGCO Equine Medication Use and Awareness Program before reinstatement;
- 2. The Licensee shall keep the peace and be of good behaviour;
- 3. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Racing Officials for any breach of the terms of their license.
