Backstretch:

#10 "Beyond Smart" scheduled to compete in todays fourth race was unable to cross the border due to incorrect paperwork, scratched

Film Reviews:

Review of races from August 8 & 9, (delayed due to covid 19 issue and the original board had to be replaced)

Race 3 August 9, Leo Salles claimed foul on Daisuke Fukumoto at the 3/16 pole. Leo said after looking at the video, realized he made an error, thought Diasuke came over on him but relizes now there was no room and he kept his path. Diasuke said he stayed straight and never moved in. Claim was disallowed and Leo was cited for a Frivilous Claim of Foul, Monetary penalty of \$200. Second incident which happened after the wire galloping out where Mr. Salles takes aim and uses his horse to make contact with Diasuke's mount. Leo said it was a bad day and he was not in a good frame of mind, I was angry. An accumulation of things, my horse was getting in but it was my fault and I made a mistake. I have apologized to my friend Diasuke and the Trainer of his horse. Penalty to be determined.

Race 7 August 8, the Steward reviewed the stretch run involving #4 ""Hekla's Aura" ridden by Darryll Holland which finished sixth and #11 "Endorphin Rush" ridden by Leo Salles. Leo said his horse was stopping and going nowhere, Darryll did come out but never caught heels, wouldn't claim for that. Darryll said he saw Leo's horse stopping and a bit off it's stride. I did come out but

was sure I was clear. After the review, no action was taken.

Races:

Race 1 – Jockey Claim of Foul (COF) by Jockey Luis Contreras aboard #10 "Nero Davola" against Justin Stein aboard #1 "Rocket Reload" for interference around the far turn, vicinity of the 1/4 pole. Justin said his horse switched leads late and stumbled a bit, believes there may be some bad footing, said he did not make any contact with Luis. Luis said Justin's horse was getting out with him and felt it caused his horse to lose momentum. After review the video evidence was inconclusive and the COF was disallowed.

Race 8 – Trainer Claim of Foul by Willie Armata of #6 "Natural Habitat" ridden by Emma Wilson against #7 "Capable " ridden by Kazushi Kimura going into the first turn, Emma said both horses didn't negotiate the turn, no reason for me to claim foul. Kazushi had the same take on it, disallowed. Second Claim of Foul was by Hannah Twomey aboard #2 "Friday Night Magic" against #7 "Capable" ridden by Kazushi going into the far turn. Hannah said she made a mistake, should have claimed foul on the #1 Boscobel" ridden by Steven Bahen, advised her that she finished second last and Steven was third last. Next time it should not require a Claim of Foul but call us to have a look. COF was disallowed. Stewards Inquiry regarding #9 "Miss Evangeline" ridden by David Moran which fell turning for home. David said her hind quarters slipped out from under her causing her to fall, upon review it does look as David explained and in the process her back legs got tangled with the horse behind her. David was attended by EMS and cleared of any injury or concussion.
