Backstretch:

Film Reviews:

Review of Race 9 on Sunday August 9 involving Luis Contreras and Simon Husbands at the top of the stretch. Luis said he was outside Simon turning for home when Simon made the move from behind the leaders and into my path, my horse lost its momentum. Simon said he moved out but didn't realize Luis was to my outside as he was behind me. When I made the move around the leaders, my horse overreacted on me, going out a bit further than I anticipated. No action taken.

Spoke with Leo Salles about yesterdays review of the third race on August 9, 2020. Mr. Salles was levied a monetary penalty of \$200.00 for lodging a frivolous claim of foul for an incident at the head of the stretch. Mr. Salles was issued a further penalty of forty five days suspension for his actions following the running of the race in which he deliberately used his mount to make contact and endanger the health and safety of another rider and horse.

Races:

Race 1 – Received an inquiry from the Trainer of #9 "Western Society" Darwin Banach as to why #7 "Uncle Howard" ridden by Leo Salles stayed out so far down the backstretch, felt it hindered his horse. We advised he kept a straight path and is able to use any part of the track as long as

he is clear. Luis also called about the issue and was told the same, Luis had the ability to choose a different path then stay to the outside, both horses dropped in at the turn.

Race 2 - #8 "Tallestofthetall" ridden by Luis Contreras unseated its rider in the post parade, running off. Scratched by the Stewards. Luis was attended and cleared to ride by EMS. #7 "Majestic Melody" ridden by Teneca Wolfe-Bell was away slow.
