Spoke with Trainer Nigel Burke re: bar shoe on his horse Master Spy in yesterdays fifth race. Nigel said the horse normally runs with the bar shoe on the right front but in the previous race, the bar piece had broke and had to run without it. When making the entry, didn't realize he needed to signify the three shoe again.

Review of yesterdays second race with Olaf Hernandez and Leo Salles and an incident going into the far turn. Daren Gomez was present. Olaf said he was just sitting behind the leaders and when we hit the turn his horse made a quick move out with him, wasn't expecting it. Leo said when Olaf came out that fast, he made contact hard and moved him out into Juan Crawford's horse.

Race 1 - Clear

Race 2 – Stewards Inquiry into the run under the wire first time around involving #4 "Silentanddiscreet" ridden by Jason Hoyte and #7 "Mia's Authority" ridden by Steven Bahen. Jason said Steve started over but I wasn't in there, my horse shied and there was no contact.

Steven said my mare did move in more than I wanted and heard Jason yell and took right off, had him outrun and never closed the space. After review, no change was made to the order of finish.

Race 3 – Clear

Race 4 - #6 "Takota" was scratched by the Veterinarian at the Gate. Observed Jockey Juan Crawford use his crop excessively, no less than twenty times, while urging his mount "Souper Pecan" through the stretch run. Mr. Crawford has a previous warning for urging so is issued a monetary penalty of \$200.00. AGCO ruling #1850862

Race 5 - #6 "Coltons Dream" broke through the doors prior to start but the rider was able to have him under control quickly. Reviewed the stretch run re: #6 "Coltons Dream" with Luis Contreras and #5 "Souper Pronto" with Olaf Hernandez. Luis said he hit his horse right handed and he moved in away from the crop, wasn't aware Olaf was inside him, said the #3 that passed him had left him plenty of room. Olaf thought the #3 horse, which finished second, squeezed Luis and in turn Luis bothered him but after review, realized that was not the case. Luis's horse finished behind Olaf's.

Race 6 - #7 "Castleton" got loose on his way to the paddock and was scratched by the Stewards. Race clear.
