Should read as follows: Reviewed the stretch run re: #6 "Coltons Dream" with Luis Contreras and #1 "Prince Sussex" with Steve Jadoo. Luis said he hit his horse right handed and he moved in away from the crop, wasn't aware Steve was inside him, said the #3 that passed him had left him plenty of room. Steve Jadoo thought the #3 horse, which finished second, squeezed Luis and in turn Luis bothered him but after review, realized that was not the case. Luis's horse finished behind Steve.
