Film Reviews:

After deliberation on the accident which took place August 2, 2020 in race 4, Jockey Keveh Nicholls was issued a ten day suspension for careless riding.

Races:

Race 1 – Jockey Devon Johnson aboard #1 Just Run With It" was observed to have struck his mount twice in the last seventy yards with the crop in the cocked position. This is the first offence for Devon and he was issued a warning. #2 "Cape Nero" with Christopher Husbands was away slow then pinched at the start. Following the race, Trainer Santino De Paola called to dispute the claim of his horse #5 "Countryside Drive". His position was that the claimant Basil Leon had misspelled his name in the Trainer portion as Basil Loon. We explained that while the hand writing is not clear, it is not a matter of substance and the claim is declared valid.

Race 2 – #6 "San Nichola Brew" ridden by Emma Wilson was fractious in the gate and scratched by the official veterinarian. Observed Teneca Wolfe-Bell aboard #8 "Majestic Melody" strike #5 "Spanish Major" ridden by Luis Contreras, in the head area at the top of the stretch when the two of them came together briefly. Luis confirmed the violation and when asked, Teneca also said she accidently hit Luis' mount as he came to her. Teneca was issued a monetary penalty of \$300.00
