Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Office:

Received a complaint from a trainer with a horse in on Thursday August 13, that after the entries were closed and the "Final" rundown was published, race 11 for Thursday August 13 was going with seven horses. However, during the drawing of the entries, a horse had been added from after the time of "Final" and eight horses were drawn. It was relayed by the race office that a late entry was submitted and accepted. There was discussion with the Racing Secretary and it was decided that going forward, once the entry box is closed and the "Final" rundown is published, no entries will be accepted. If a race doesn't fill, horses within that race will be able to opt in to another race on the card as they were already box.

Film Reviews:

Review of yesterdays seventh race involving Jockeys Darryll Holland and Leo Salles will be carried over until Thursday August 13 due to Mr. Holland being absent today.

Races:

Race 1 – Clear

Race 2 – #6 "Lefootwostomps" ridden by Justin Stein bore out hard with him most of the trip.

Race 3 – Jockey Claim of Foul by Leo Salles aboard #2 "Exellorator" against #4 "Dragon's Brew" ridden by Diasuke Fukumoto for interference at the top of the stretch. Leo said he was making his move between horses when Diasuke came over and took his space, said it put him on the heels of the horse to the inside, said he would have won if Daisuke didn't interfere with me. Daisuke said not sure were he was going, there was no room, he tried to bounce me out, there was no reason for that. After review it is apparent that Mr. Salles was attempting to go between Daisuke and Patrick Husbands on #6 "Wora", there was no room and he tried to make room by bumping Diasuke out. Claim of Foul is disallowed. We observed that after the race was over and just past the wire, Mr. Salles used his horse to run into Diasuke and his mount creating an unsafe situation. Notice of Review was sent to the Jockeys quarters for Mr. Salles.

Race 4 - Clear, After the finish and galloping out, #1 "Gunner Ben" ridden by Jason Hoyte catches the heels of #9 "Conquest Eliminatr" ridden by Carl Defreitas and falls after that one bounced off the inside rail and into his path. Rider and horse were ok. Jason was examined by EMS and cleared of any concussion symptoms.

Race 9 - #1 "Dancing Derek" was a vet scratch at the gate. Stewards Inquiry into the an incident at the top of the stretch involving #3 "Victor's Destiny" ridden by Simon Husbands and #8 "Mc Culley" with Luis Contreras. Simon said he went around horses at the top of the stretch, didn't bother anyone, when asked about the horse to his outside, he said there was no one to his outside. Luis said he was making a move to go around Simon and he moved out in front of me. I was on his heels and had to check, stopped my momentum, probably would have beaten him. After review we disqualified #3 from second and placed it third behind #8.

Race 10 – Stewards inquiry and Trainer/Jockey Claim of Foul by Julie Belhumeur against both #2 "Tranquility Base" ridden by Kazushi Kimura and #10 "Animal Krackers" with Rafael Hernandez for interference at the top of the stretch and approaching the wire. Sunny Singh also placed a Claim of Foul against both #2 and #10 at the top of the stretch. Rafael said his horse was getting strong with him, did his best to keep him out, never did this with me before. Sunny said Rafael came over and pushed him down on top of horses to the inside. We disqualified Rafaels horse from second and placed him eighth behind Sunnys horse for this incident. Second incident was approaching the wire, Kazushi said he was keeping straight when the two horses to his outside kept coming down, the #5 hit my hind quarters and my horse lost balance and was turned out because of that. Christopher husbands on the #5 said that both the #2 and #10 squeezed him coming to the finish, Rafael was pushing in towards the #2 and that one turned out in front of me. Rafael said as before that his horse never let up lugging in, did his best to keep straight. After review #10 and #5 are heading in towards the #2 and into that one, the #2 gets hit in the hind quarters initiated by #5 which turns him outwards. Claim of foul o #2 was disallowed.
