Race 8 – The Jockey Club Stakes - Jockey Claim of Foul (COF) by Luis Contreras aboard #6 “Eskiminzin” against #9 “Mason’s Gamble” ridden by Rafael Hernandez for interference in the vicinity of the quarter pole. Luis said he was in tight with horses to his inside when Rafael came over on him and he had to get out of there. Rafael said he kept his path, said it was tight all around and if anything, the inside came out to him. After review, the video evidence was inconclusive and the COF was disallowed.

Race 9 – Jockey Claim of Foul (COF) by Leo Salles aboard #5 “Sir Sahib” against #3 “Palazzi” ridden by Declan Carroll for interference in late stretch. Leo said Declan’s horse was coming out through the stretch and I had to change direction and lose momentum. Declan said Leo was laying on me around the turn, down the lane not sure what to say, I came out a bit but he was never there, I was running away from him. After review it was apparent that Leo was behind but not close to Declan and when he changes directions he is at least a length and one half behind Declan. the COF was disallowed.
