This is his third offence within a calendar year and is assessed a monetary penalty of \$500.00 and levied a three day suspension. The days for suspension will be determined following the outcome of a pending Horse Racing Appeal Panel (HRAP) appeal, that Mr. Salles has submitted a request to withdraw.

Review of yesterdays last race with Apprentice Hannah Twomey. Present were Irwin Driedger, Steven Bahen and David Moran. Hannah said she was trying to get her horse back but obviously not fast enough, then my horse jumped on the bit and that's when I caught the heels of Moran's horse at the 5 ½ pole. After discussion it was determined that Hannah be levied a five day suspension for careless riding. Days to be determined.

Justin said Steve move out and into him, knocking his horse out and onto the heels of the #4 horse. I was in a bad spot. After review, #2 with Bahen was disqualified from fourth and place seventh behind Justin's horse.
