Patrick said he was taking back off the front runners and when he moved in, there was no one beside me, didn't see Justin as he wasn't there when I made the move.

Review of the eleventh race with Leo Salles and Justin Stein going into the Club house turn. Leo said his horse is pretty green and ran in with him quicker than he anticipated, grabbed his horse as best he could and pulled off immediately. Justin said it happened very quickly and with two year olds, they shy easily.

Jockey's Guild Executive Manager Irwin Driedger and Jockey's representative Emma Wilson were both present. Under the new protocols with the riders, they were both issued warnings and any future incidents similar in nature will be dealt with more severely.
