A further COF was lodged by Tony Gattellaro, the Trainer of #4 "Desert Poem" ridden by Luis Contreras against #2 for interference during the same incident. David said the horse came out and stopped him causing him to check, was on her heels and she forced me out into the horse to my outside. Emma said she did move out but was running on by, thought she was clear. Luis said his horse was bumped in the hind quarters causing him to lose action, my horse was moving fast and it may have cost me the win. After review, we disqualified #2 from first position and placed it fifth behind #5.
