Race 4 – The Vice Regent Stakes – Stewards Inquiry and Jockey Claim of Foul (COF) by Justin Stein aboard #3 "Silent Poet" against #4 "Warp Ride" with Eswan Flores and #7 "Rockcrest" with

Keveh Nicholls for interference going into the far turn. Justin said I was yelling loud that I was in there and had the #1 to my inside, yelled real loud and they just kept coming. Eswan said the turn was coming up real fast and the pressure was coming from my outside, couldn't help the guys inside me. Keveh said he stayed his path, just trying to stay tight to the horse to my inside #4, stayed with him, did not move from my path. Rafael who was on #1 "Mason's Gamble" said Justin was yelling but the outside horses kept coming over, hit the fence hard. After review, we disqualified #7 "Rockcrest" with Nicholls from third and placed him seventh behind #3 Silent Poet".

A second COF was lodged by Jason Hoyte aboard #6 "Wedgewood" which finished second against the winner #2 "Forester's Fortune" with Daisuke Fukumoto for interference going into the far turn. Jason said the two came right out and into my path. Daisuke said the #3 "Silent Poet" was interfered with in front of him and came straight back into his horse's path, just tried to avoid that one, nothing I could do. The second COF was disallowed.

Race 5 - #6 "Jilli Marie" with Steven Bahen broke awkwardly

Race 6 – Stewards Inquiry and Jockey Claim of Foul (COF) by Skye Chernetz aboard #3 "Loki's Lighting" against #2 "Acquired Taste" ridden by Declan Carroll for interference during the stretch run. Skye said I had a clear path and my horse was still full of run when the #2 came over and side swiped my horse hard and into the horse to my inside. Declan said I know it looks ugly but just as I went for the hole the horse in front moved over at the same time and the room diminished. After review #2 was disqualified from second and place last behind #3 and #1.

Keveh said I am all the way in there and Emma squeezed me into the fence, I hit the fence hard, white all over my boot, don't know why she squeezed me. Emma said I knew Keveh was in there, gave him room, he must have come out to me and turned my horses rear out. I was staying off the heels of the #2 horse in front me. I stayed in my path. After review, we disqualified #3 from first and place it seventh behind #1.
