Film Reviews: Yesterdays races 4, 6 and 7. Present was Jockey's Guild Manager Daren Gomez

Race 4 – Keveh Nicholls, Eswan Flores and Justin Stein. Justin said I was yelling at the top of my lungs to the horses outside that I was there and had one to my inside. No response from either, just kept coming in, was in a real bad spot. Eswan said going 5/8 on the turf, the turn was coming fast and had pressure to my outside, had my horses head cocked out but nowhere to go. Keveh said he was following Eswan's horse in, never made contact with him. It was mentioned that Keveh went from the four path to the three and Eswan went from three to two. Three day suspension for Keveh.

Race 6 – Declan Carroll and Skye Chernetz. Declan said he was full of run and went for the hole to the inside, was committed when the horse in front came in at the same time and the room diminished, went into Skye pretty good. If I was to stop riding and pull out I might be on heels. Skye said her horse was full of run when Declan came over and side swiped me hard, caused me to go into the horse to my inside. Three day suspension for Declan.

Race 7 – Emma Wilson and Keveh Nicholls. Keveh said he was head and head with Emma, she gave me room to get in there. Then she squeezed me and I hit the fence hard, took me completely out of the race. Emma agreed she gave him room and was in there, felt Keveh came out to her and knocked her horses hind end causing her to turn in. Why would I let him in there then shut him off. Had to stay off the heels of the #7, felt she kept her path. Three day suspension for Emma.
